O R D E R

We have perused the Report submitted by the Commission headed by Justice D. P. Wadhwa. The Report is very comprehensive and gives a detailed analysis of various aspects which needed to be addressed. There is unanimity at the Bar that the Report deserves acceptance. Therefore, we direct acceptance of the Report. In terms of the earlier order, let simila r exercise be undertaken by the Commis sion for the entire country, because the factors highlighted by the Commis sion are not restricted to Delhi alone, and appear to be prevalent throughout the country.

The Commission is requested to submit its Report within a period of six months. The earlier modalities relating to salary etc. shall be continued. The various suggestions given and shortfalls noticed by the Commis sion shall be addressed after the subsequent Report is received.

The order dated 28. 11. 2001 is modified to the extent that the allotment shall be 35 KG in view of the increase, subsequent to the order.
