2. Mr. Colin Gonsalves, learned Senior Counsel appearing for the petitioners in W.P.(C) Nos.3146/2012, 4425/2012 & 4588/2014 as well as Mr. Gautam Narayan, learned Addl. Standing Counsel for the Govt. of NCT of Delhi prays for a short time to examine these matters and consolidate the issues which require to be to heard and addressed by this Court.

3. Our attention is drawn to an order dated 19th September, 2017 passed by the Supreme Court in *Re: Inhuman Conditions Prevailing in 1,382 Prisons*, wherein it was directed for constitution of a Board of Visitors which include non-official visitors of considerable importance so that eminent members of society can participate in initiating reforms in prisons and in the rehabilitation of prisoners in terms of Chapter XXIX of the Model Prison Manual, issued by the Ministry of Home Affairs, Government of India. It was also directed for brining the Jail Manual of different States in line with the Model Prison Manual framed and issued by the Ministry of Home Affairs, Govt. of India. *W.P.(C) 3146, 4425/2012, 1449, 4588/2014 & W.P.(Crl.)1138/2014 Pg. 4 of 5* 4. Mr. Gautam Narayan, learned ASC submits that the Govt. of NCT of Delhi has effectively worked on the amendments to the Jail Manual regarding the Board of Visitors and the draft proposal is pending with the Lt. Governor of Delhi.

5. Mr. Gautam Narayan submits that the proposed amendments by the Govt. of NCT of Delhi would effectively bring the Jail Manual in line with the draft Model Guidelines suggested by the Government of India. He prays for a short adjournment to place the position regarding the amendments of the Jail Manual.

6. Let a copy of the draft proposal be also made available to Mr. Colin Gonsalves, learned Senior Counsel appearing for the petitioners, who may examine the same.

7. It shall be open for the learned counsel for the parties to request the Registry to provide digital copies of the abovementioned matters mentioned in para 1, if the same are available.
