- **1.** This petition has been preferred praying mainly for the following reliefs:
 - "a. For immediate direction to the respondents concerned to provide proper health and medical assistance and shelter to a mentally traumatized victim of rape who was found by Rail Madhupur Police on 02.09.2015 in naked condition, later she was kept in Petitioner's organization namely Prerana Bharati (a society registered under Society Registration Act), Madhupur, District-Deoghar.
 - b. For immediate direction to the respondents for proper investigation of Madhupur Rail P.S. Case No. 70/2015 dated 03.08.2015 registered U/s 376 & 307 of Indian Penal Code by a competent police officer in order to identify and arrest the culprits as earliest.
 - c. For any other writ(s), order(s), direction(s) as your lordship deem fit and proper in the eye of law."
- **2.** Having heard counsel appearing for both sides and looking to the facts and circumstances of the case and affidavit filed by the respondents, it appears that one lady was found in unconscious condition in Madhupur Railway station in the District of Deoghar on 2nd September, 2015.

- 3. It further appears that thereafter, this woman was immediately Bharti, which Prerana is а Non Governmental Organization(Hereinafter to be referred to as N.G.O) operated by this petitioner. Thereafter, she was shifted to Ranchi Institute of Neuro Psychiatry & Allied Sciences, Ranchi (Hereinafter to be referred to as RINPAS) where necessary tests were carried out and she was found HIV-I -Reactive. She was referred to Rajendra Institute of Medical Science, Ranchi by the Doctors of RINPAS, Ranchi from where she was again sent to Prerana Bharti, which showed its inability to keep her and therefore, she was sent to another N.G.O, viz. Bokaro Mahila Jan Swasthya (Shishu) Kalyan Kendra on 11th October, 2015 and thereafter, she ran away from the said institution on 20th November, 2015. The President of the said N.G.O. at Bokaro informed the Chas Police Station and since then the investigating officer is searching the said woman.
- **4.** Counsel appearing for the State has submitted that several attempts have been made by several police stations at various places to trace out the said lady. Assistance of print as well as electronic media like NEWS 11 and other local channels has also been taken.
- 5. Thus, looking to the attempts made by the respondent State, it appears that the search for the said woman is still going on. Therefore, in view of the attempts made by the concerned police station, we see no reason to monitor this case further because it appears that the police department has left no stone unturned in searching out the victim lady and it is expected from the State of Jharkhand that immediately after the said lady is found she will be given proper treatment to improve her health.
- **6.** With this observation, this writ petition is disposed of.
