in some of the writ applications. Accordingly, learned counsel for the petitioners are directed to remove the defect within a period of one week from today.

Heard learned counsel for the petitioners, learned Advocate General, counsel for the Union of India as also counsel for the Municipal Corporation.

The water logging is a recurring problem which is happening everywhere in the city of Patna. For the present, the citizen of Patna is still facing the problem of water logging in certain areas and also reports have come through newspaper that the people are suffering from Dengue fever and one of the member of the Bar has already died on account of Dengue fever which is a very serious matter. Reports have also come from paper that at least 55 persons have died as a result of Dengue fever.

As large number of writ petitions have been filed, certainly, it will take time to file detail reply by the State. Accordingly, we give four weeks' time to State to file counter affidavit in the matter against all the writ applications.

The festival is coming fast. Chhath puja is going to be celebrated on 31st of October, 2019. It is expected that the Ghats will be brought to a proper shape so that the persons, who are



observing Puja, will have an easy approach to the Ghat. At the same time, the Government must ensure draining out the water and make the residents ease who are under severe constrain. This Court also directs the State Government as well as the Municipal Corporation to take steps to prevent spreading of Dengue and they must take it at a war-footing by cleaning each area and specially those area which have remained under water for a long time. It is also expected from the Municipal Corporation, it will remove the garbage from different places of the city without delay. It is not only causing great harm to the citizen of the city specially but, also spreading the menace of Dengue mosquito. This Court again directs the State Government Authorities as well as the Municipal Corporation to show sensitivity that whenever any phone call comes, they must receive it and give proper reply. They must also reflect the phone number as well as the name of officers in the web-site as well as in paper who are also supposed to give response when ever a citizen is making a complaint about litter in their area.

We direct the Municipal Corporation to give the telephone number, area-wise officer who can give valuable assistance to the citizen of that area.

The State must file detail counter affidavit, that apart, will give detail on following points:-

- 1. Name of officer related to cleaning of sewerage and
- 2. Name of Contractor engaged in cleaning the Nala and other pipe-line leading to draining out the water.
- 3. Give detail with respect to the Sump Houses that were working during that period.
 - 4. What step was taken after Meteorological forecast.
- 5. How much money utilized in clearing the sewerage pipeline.

Let all these cases be listed on 25.10.2019. On that day, the State will file its report with regard to the position of water logging as also the position of Chhath Ghat.
