## APPLICATION FOR DIRECTIONS ON BEHALF OF THE APPLICANT/INTERVENOR

- 1. That the above mentioned Contempt petition in the captioned Writ Petition was filed to ensure implementation of the order passed by this Hon'ble Court in Writ Petition (C) No. 365 of 2006, which was filed before this Hon'ble Court under Article 32 of the Constitution of India to ensure timely payment of wages to the tea garden workers in different states. The writ petition was disposed of by an order dated 06.08.2010, by which the Central Government was directed to carry out their statutory duties, in terms of Sections 16-B, 16-C, 16-D and 16-E of the Tea Act, 1953 within a period of six months. As the direction issued by this Court was not complied with, the Petitioner filed the above contempt petition.
- 2. That the applicant/intervenor is a registered trade union of Assam having its registered office at Borgang in Biswanath district of Assam. The registration number of the petitioner trade union is 1133. It is also affiliated to the All India Central Council of Trade Unions (AICCTU). There are more than 25000 tea garden workers who are members of the petitioner trade union. The petitioner trade union is primarily engaged in issues of the workers of tea estates of Assam. After the lockdown on account of COVID-19 virus, the applicant is being approached by several tea garden workers regarding non-payment of wages and ration in different tea gardens in Assam. Hence the applicant is filing this application seeking urgent listing of the application and immediate relief for the workers.

#### **BACKGROUND**

3. On 04.04.2018, this Hon'ble Court passed a detailed order in the Contempt Petition directing the Union of India and respondent states to ensure timely payment of wages to the workers. The copy of the order dated 04.04.18 is at **Annexure A-1 at page 20 to 40.** Regarding state of Assam, this Hon'ble Court passed the following directions:

**`**...

- (i) State of Assam is directed to complete the process of appropriation within a period of 60 days from today. The MOU shall also be signed during this period.
- (ii) In the meanwhile, the State Government along with Corporation shall update the list of unpaid retired workers and notify them that they would pay the amounts. For this purpose the workers shall appear and have their identities and claims duly verified.
- (iii) The State Government would put in hand the necessary funds of Rs. 99 Crores to the Corporation which shall disburse the said amount upon verification of these retired employees.
- (iv) In case the workers have died, the amounts shall be disbursed to the legal representatives upon verification of their status by the Corporation.

- (v) Upon verification of their identities and claims they shall make payment in chronological order, i.e., those who have retired earlier shall be paid before those who have retired later.
- (vi) The process of verification and identification shall be commenced immediately.
- (vii) The Government shall be entitled to recover those amount from all those employers whose primary duty was to pay the wages, as a revenue demand or any other efficacious manner.

...."

4. After order dated 04.04.2018 was passed, The State of Assam disbursed Rs.76 Crores out of Rs.99 Crores which was directed to be deposited by this Court, vide order dated 04.04.2018. The state of Assam made only partial payment to the workers, however the total dues of the workers remained unpaid. Processing of payment of dues, document verification and identification has only commenced in 15 ATC gardens. The management authority in all Tea Estate has categorized the workers in 3 classes A1 (consisting of retired alive persons), B1 (consisting of retired persons who are not alive) and C1 (consisting of running workers). Amounts are being disbursed to workers in chronological manner starting with A1 category first. Thus, the due wages of the workers remains unpaid till date.

- 5. This Hon'ble Court further passed an order on 11.12.19, appointing a one person committee of a retired Supreme Court judge (Hon'ble Justice (retd.) Amitava Roy to adjudicate the dispute relating to wages of the workers in all the four states- Assam, West Bengal, Tamil Nadu and Kerala. By this order, this Hon'ble Court also directed the tea Gardens to deposit a sum of Rs. 2 crore with the State Government. The copy of the order dated 11.12.19 is annexed herewith as **Annexure A-2 at page 41 to 46.**
- its order dated 11.12.19 and appointed Hon'ble Justice Mr. Abhay Manohar Sapre (retd.) as the head of one person committee. This Committee started its proceedings and the first meeting in Assam was held on 26.02.2020, whereby one person committee directed all the Tea Estate Garden owners to deposit a sum of Rs. 2 crore pursuant to the order dated 11.12.19 passed by the Hon'ble Supreme Court. The copy of the minutes of the meeting dated 26.02.2020 held in Assam is annexed herewith as **Annexure A-3** at page 47 to 49.

#### LOCKDOWN ON ACCOUNT OF COVID-19

7. That, on account of COVID-19 which has been declared as a pandemic by the World Health Organisation (WHO) and to prevent

its spread across the country, the National Disaster Management Authority, in exercise of powers under Section 6(2)(i) of the Disaster Management Act, 2005, issued an order dated 24-03-2020 directing Ministries/Departments of Government of India, State Governments and State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 in the country. It was further ordered that the said measures shall be in force for a period of twenty-one (21) days with effect from 25<sup>th</sup> of March, 2020. Thus the period of lockdown is extended till 14.04.2020 and is likely to be further extended in different parts of the country.

#### MEASURES FOR MIGRANT WORKERS

8. That the Hon'ble Home Secretary, Ministry of Home Affairs, Government of India, in order to ensure effective implementation of the lockdown measures and to mitigate the economic hardship of the migrant workers, in the capacity of Chairperson, National Executive Committee and in exercise of powers under Section 10(2)(I) of the Disaster Management Act, 2005, through Order No. 40-3/2020-DM-I(A) dated 29-03-2020, directed the State/Union Territory Governments and State/Union Territory Authorities to take necessary action and to issue necessary orders to their District Magistrate/Deputy Commissioner and Senior Superintendent of Police/Superintendent of Police/Deputy Commissioner of Police to

take certain additional measures. True copy of the Order No. 40-3/2020-DM-I(A) dated 29-03-2020 issued by the Ministry of Home Affairs, Government of India is attached herewith as **Annexure A-4 at page 50 to 52.** The relevant part of the order is as under:

"All the employers, be it in the industry or in the shops and commercial establishments, shall make payment of wages of their workers, at their work places, on the due date, without any deduction, for the period their establishments are under closure during the lockdown."

9. That the Government of Assam after receiving information regarding non-payment of wages and ration to the plantation workers by the tea garden owners, on 02.04.2020 issued a circular directing all the plantation owners to disburse the wages and ration to the plantation workers during the period of lockdown. The copy of the order dated 02.04.20, issued by the Government of Assam is annexed herewith as **Annexure A-5 at page 53 to 56.** 

#### NON-PAYMENT OF WAGES IN TEA ESTATES OF ASSAM

10. That, as per the information available in the website of the Tea
Tribes Welfare Department, Government of Assam, there are 803
tea estates in the state of Assam. Also, there are about ten lakh
tea garden workers in the state of Assam and as per the

information collected by the applicant trade union, the workers of the tea estates of Assam have not been paid any wages for the period during which the tea estates have been under closure due to the lockdown. At present, the cash component of the wages paid to tea garden workers is Rs. 167 in the Brahmaputra valley whereas it is Rs. 145 in the Barak valley. Additionally, foodgrains in the form of rice and flour (*Atta*) is also provided to the workers on the following basis:

11. That the applicant/intervenor union has collected information regarding wages paid to the workers in some tea estates during the lockdown period. They found that no wages have been paid to the workers of those tea estates for the period during which the tea estates were under closure due to lockdown. Some of the information as collected by the applicant is reproduced below:

12. That the President and General Secretary of the petitioner organization had written a representation via email dated  $7^{th}$  April,

2020, to the Labour Commissioner of Assam requesting him to take appropriate action against the employers/management of all tea estates for violating Government Orders and to also take appropriate steps to ensure that the tea garden workers immediately receive the wages for the lockdown period. But there hasn't been any concrete steps taken by the Respondents towards fulfillment of the requests made by the petitioner. True copy of the representation dated 07-04-2020 written on behalf of the applicant union to the Labour Commissioner of Assam is attached herewith as **Annexure A-6 at page 57 to 61.** 

13. Despite specific government orders were passed and demands were raised by different workers union in several tea gardens, workers are not being paid their wages and rations by their employers. The workers in the tea gardens are in dire circumstances and facing extreme poverty. The earlier reports from the tea gardens suggest many starvation deaths due to non-payment of wages. With the lockdown this situation will further aggravate and may put many lives at stake. It is for this reason, that the present application is being filed by the applicant seeking urgent listing of the matter and immediate relief in terms of disbursement of wages and ration to the tea garden workers.

- 14. That the applicant has not filed any other or similar application/petition before this Hon'ble Court or any other Court seeking similar relief.
- 15. That this Hon'ble Court has jurisdiction to entertain the present application and pass relief as prayed by the applicant.

#### **PRAYER**

- 16. It is therefore prayed by the Applicant that this Hon'ble Court may kindly be pleased to pass an order:
  - i. Directing the State of Assam (Respondent No. 5 in Writ Petition (C) No. 365 of 2006) to ensure that workers in all the tea gardens in the State of Assam are paid wages and ration immediately including for the period of lockdown.
  - ii. Directing the State of Assam to strictly implement the order dated 29.03.2020 issued by the Ministry of Home Affairs, Government of India (Annexure A-4 herein) directing payment of wages to all the migrant workers.
  - iii. Directing the State of Assam to strictly implement its order dated 02.04.2020 issued by the office of Labour Commissioner, Government of Assam.
  - iv. Directing the State of Assam to take necessary action on the representation dated 07.04.2020 submitted by the applicant/intervenor, giving details of the pending dues in different tea gardens in Assam.

v. Pass any other order which this Hon'ble Court may deem fit in the facts and circumstances of the present case.

#### **ORDER**

In this case, we find that workmen, who worked for about 20 years have not been paid their wages. Their condition is pitiable and some of them have resorted to commit suicide. In some cases, these workmen are part of an unorganized Sector. In some cases proceedings have been initiated by the workmen and in some cases by the Government for recovery of dues. The amounts have been locked in litigation and without any relief to the workers. Having regard to these circumstances, we consider it appropriate to hear the State

Government on the question of interim relief that may be granted to the workmen.

#### **IN RE: ASSAM**

The State Government has responded to the proposal in a most positive manner. Shri Maninder Singh, learned Additional Solicitor General appearing for the State of Assam has stated that there are about 16,133 retired workers and staff of the corporation, many of whom had retired over 20 year back and 839 retired persons but continuing in service. The Corporation owns 15 Tea Estates in the State of Assam. It is also stated across the Bar that appropriation, i.e., the money would be placed in the hands of the Executive within a period of 90 days. However, an MOU would be signed by the State Government and the Assam Tea Corporation during that period.

In these circumstances, we pass the following order:

- (i) State of Assam is directed to complete the process of appropriation within a period of 60 days from today. The MOU shall also be signed during this period.
- (ii) In the meanwhile, the State Government along with Corporation shall update the list of unpaid retired workers and notify them that they would pay the amounts. For this purpose the workers shall appear and have their identities and claims duly verified.

- (iii) The State Government would put in hand the necessary funds of Rs. 99 Crores to the Corporation which shall disburse the said amount upon verification of these retired employees.
- (iv) In case the workers have died, the amounts shall be disbursed to the legal representatives upon verification of their status by the Corporation.
- (v) Upon verification of their identities and claims they shall make payment in chronological order, i.e., those who have retired earlier shall be paid before those who have retired later.
- (vi) The process of verification and identification shall be commenced immediately.
- (vii) The Government shall be entitled to recover those amount from all those employers whose primary duty was to pay the wages, as a revenue demand or any other efficacious manner.

We are conscious that the total number of garden whose workers are unpaid is about 22. For this purpose we consider it appropriate to pass orders in relation to other gardens after hearing the owners. The list of gardens which are not owned by the Assam Tea Corporation is as follows:

The State of Assam is directed to notify the owners of those Tea gardens about these proceedings before us. Accordingly issue notice to those above Tea gardens through their companies/managment returnable in two weeks.

#### IN RE: WEST BENGAL

We are informed by the Central Government that in the State of West Bengal there are pending dues of workmen. Shri Gonsalves, learned senior counsel for the petitioner submits that according to Central Government affidavit, Rs. 30 Crores are unpaid. These dues

are apparently not paid in respect of workmen who were employed by 45 Tea Gardens.

On the question of interim relief which we propose to pass Shri Banerji learned senior counsel for the State of West Bengal submitted that there is no negligence by the State regarding unpaid workers. On the contrary, the State has spent large amounts on the development of various schemes for those workers as mentioned on pages 25-26 of the Additional affidavit filed by the State of West Bengal. It appears that this is so. We, however, see no reason why the State should not temporarily spent further amounts for paying dues to workers of an unorganized sector in respect of wages due to them for work actually rendered.

Having regard to the plight of the workers and the pitiable conditions in which they are living we consider it appropriate in the interest of justice to pass the following order:

- (i) The State Government would pay the necessary funds of Rs. 15 Crores to the employees upon verification within 60 days. (ii) Notices shall be issued to the workers to present their claims and only upon verification the said amounts shall be disbursed to them.
- (iii In case the workers have died, the amounts shall be disbursed to the legal representatives upon verification their status.

- (iv) Upon verification of their identities and claims they shall make payment in chronological order, i.e., those who have retired earlier shall be paid before those who have retired later.
- (v) The process of verification and identification shall be commenced immediately.
- (vi) The Government shall be entitled to recover those amount from all those employers whose primary duty was to pay the wages, as a revenue demand or any other efficacious manner.

- (iii In case the workers have died, the amounts shall be disbursed to the legal representatives upon verification of their status.
- (iv) Upon verification of their identities and claims they shall make payment in chronological order, i.e., those who have retired earlier shall be paid before those who have retired later.
- (v) The process of verification and identification shall be commenced immediately.
- (vi) The Government shall be entitled to recover those amount from all those employers whose primary duty was to pay the wages, as a revenue demand or any other efficacious manner.

- (v) The process of verification and identification shall be commenced immediately.

(vi) The Government shall be entitled to recover those amount from all those employers whose primary duty was to pay the wages, as a revenue demand or any other efficacious manner.

UPON hearing the counsel the Court made the following

#### **ORDER**

1. Aggrieved by the non-payment of dues to the plantation workers, the Petitioner filed Writ Petition (C) No. 365 of 2006. The writ petition was disposed of by an order dated 06.08.2010, by which the Central Government was directed to carry out their statutory duties, in terms of Sections 16-B, 16-C, 16-D and 16-E of the Tea Act, 1953 within a

period of six months. As the direction issued by this Court was not complied with, the Petitioner filed the above contempt petition.

- 2. After hearing the learned counsel for the parties, a detailed order was passed on 04.04.2018 by this Court giving directions to the States of Assam, West Bengal, Tamil Nadu and Kerala, to pay the dues of the retired workers. After obtaining the information about the dues payable to the workmen from the Union of India, the State of Assam was directed to make available Rs.99 Crores to the Assam Tea Corporation, which was directed to be disbursed to the workmen, after verification of their claims. Likewise, the States of West Bengal, Tamil Nadu and Kerala were also directed to provide Rs.15 Crores, Rs.9.5 Crores and Rs.2.79 Crores respectively for the purpose of payment of the dues of the workers.
- 3. The status report filed on behalf of the Petitioner regarding compliance of the order dated 04.04.2018 shows that the directions issued by this Court have been partially implemented by the State Governments. The State of Assam disbursed Rs.76 Crores out of Rs.99 Crores which was directed to be deposited by this Court, vide order dated 04.04.2018. Similarly, the State of West Bengal had disbursed only Rs.12.18 Crores out of Rs.15 Crores which was directed to be paid and the State of Tamil Nadu had disbursed Rs.8 Crores out of Rs.9.5 Crores. The State of Kerala has not disbursed any amount as per the status report filed by the Petitioner.

- 4. Mr. Rakesh Dwivedi, learned Senior Counsel appearing for the State of West Bengal made some suggestions regarding the redressal of the grievances of the workers. Mr. Colin Gonsalves, learned Senior Counsel appearing for the petitioner, Ms. Vibha Datta Makhija, learned Senior Counsel appearing for the Union of India and Mr. Narender Hooda, learned Senior Counsel appearing for the Tea Board have no objection to this Court accepting the suggestions made by Mr. Dwivedi.
- 5. We accept the suggestions made by Mr. Dwivedi as mentioned above with the following modification in paragraph No. 1 and paragraph No.9.
- 6. Paragraph No.1 shall be modified to state that Mr. Justice Amitava Roy, retired Judge of this Court, shall head the One-Member Committee instead of Justice (Retd.) Kalyan Jyoti Sengupta as suggested by the State of West Bengal. Paragraph No.9 shall stand modified to state that the additional costs in the process of disbursement of dues shall be borne by the State Governments instead of the Tea Board. Subject to the above modifications, the suggestions of the State of West Bengal are accepted. The workers are directed to approach the One-Member Committee for settlement of their claims. The connected records shall be made available to the One Member Committee by the State Government, Tea Board and the Tea Gardens, as and when required. As per the suggestions made on behalf of the State of West Bengal, each Tea garden shall deposit an amount of Rs.2 Crores. All the Tea gardens are directed to deposit the said

amount. In case any tea garden has paid all the dues of the workmen, they may approach the One-Member Committee for refund of the

amount deposited.

7. The suggestions made by the State of West Bengal shall be

furnished to the Advocates-On-Record for the States of Assam, Tamil

Nadu and Kerala. They may come forward with proposals for

disbursement of the dues of the workmen of the tea gardens. The

process of disbursement of the dues to the workmen may be expedited

by the One-Member Committee as the payments have been pending

for a very long period of time.

The State and its agencies such as Labour Department, Provident Fund Department and Tea Board are also granted an opportunity to file/produce entire record relating to each Tea Estate Garden Owners or the workers in question in respective of each Tea Gardens specified

in the SC order with a view to verify various claims of the Tea Estate Garden workers against them.

Let this be filed by the next date of hearing.

The Trade Unions who are not parties to the writ petition have also appeared of their own today. These unions are also granted an opportunity to file statement in relation to their grievances, duly supported with the affidavits.

Let this be filed by all such Trade Unions by the next date of hearing.

Indian Tea Association is also granted time to file their submission/statement in case if they so wish, by the next date of hearing duly supported with the affidavit.

#### **ORDER**

Whereas, in exercise of the powers, conferred under Section 10(2)() of the Disaster Management Act, the undersigned, in his capacity as Chairperson, National Executive Committee, has issued an Order of even number dated 24.03.2020, followed by Addendum Orders of even number dated 25.03.2020 and 27.03.2020 to the Ministries/ Departments of Government of India, State/Union Territory Governments and State/ Union Territory Authorities with the directions to implement lockdown measures annexed to the said Orders for the containment of spread of COVID-19 in the country;

Whereas, movement of a large number of migrants have taken place in some parts of the country so as to reach their hometowns. This is a violation of the lockdown measures on maintaining social distance;

Whereas, to deal with the situation and for effective implementation of the lockdown measures, and to mitigate the

economic hardship of the migrant workers, in exercise of the powers, conferred under Section 10(2)(I) of the Disaster Management Act 2005, the undersigned, in the capacity as Chairperson, National Executive Committee hereby directs the State/Union Territory Governments and State/ Union Territory Authorities to take necessary action and to issue necessary orders to their District Magistrate/ Deputy Commissioner and Senior Superintendent of Police/ Superintendent of Police Deputy Commissioner of Police, to take following additional measures:

- State/Union Territory Governments shall ensure adequate arrangements of temporary shelters, and provision of food etc. for the poor and needy people, including migrant labourers, stranded due to lockdown measures in their respective areas;
- II. The migrant people, who have moved out to reach their home states/ home towns, must be kept in the nearest shelter by the respective State/Union Territory Government quarantine facilities after proper screening for a minimum period of 14 days as per standard health protocol;
- III. All the employers, be it in the Industry or in the shops and commercial establishments, shall make payment of wages of their workers, at their work places, on the due date, without any deduction, for the period their establishments are under closure during the lockdown;

IV. Where ever the workers, including the migrants, are living in rented accommodation, the landlords of those properties shall

not demand payment of rent for a period of one month.

V. If any landlord is forcing labourers and students to vacate their

premises, they will be liable for action under the Act.

It is further directed that in case of violation of any of the above

measures, the respective State/UT Government, shall take necessary

action under the Act. The District Magistrate/ Deputy Commissioner

and Senior Superintendent of Police Superintendent of Police/ Deputy

Commissioner of Police will be personally liable for implementation of

the above directions and lockdown measures issued under the above

mentioned Orders.

Respected Sir,

Today is the 14th day of lockdown declared by the Hon'ble Prime Minister of India. Keeping in view the condition of daily wage earners of Tea industry during the period of lockdown, the central govt vide Order no. 40-3/2020-DM-I(A) dated 29.03.2020 directed all tea gardens owners to pay wages to the workers for this period. Subsequently the Govt of Assam also vide Letter of Labour Commissioner bearing no. PLA. 7/06/Pt-I dated 02.04.20 reiterated the same directions.

But, with much sadness we beg to inform you that most of the workers of the tea industry of Assam have not received any wages or ration for the period of lockdown till 6<sup>th</sup> of April, 2020. As a result, their family conditions have become very grave. Due to this, the starving tea workers of Baghmari Tea Estate of Biswanath District have started revolting.

Furnished below is information about how wages & ration have been disbursed to the workers of some tea gardens situated of Biswanath and Dibrugarh districts:-

Bihali constituency under Biswanath district:

#Bedeti, Borajuli & Bihali Tea Estates:

Owned by McLeod Russel. Wages are paid weekly. The workers received payments on 28<sup>th</sup> March, 2020 for the works done in the previous week. They did not receive any payment for the lockdown period. In terms of ration, on 6<sup>th</sup> April, 2020, they received only atta (flour), but no rice. In the form of Government aid, all workers, whether permanent or temporary, received 4 kg rice. Those without ration card have received 3 kg rice, 250 gm lentils, 1 kg potato, 1 packet of salt worth Rs 5/-; but many families have not received even this help.

#Ketela Tea Estate (Owner: H.M. Pincha) Wages are paid bi-monthly. Workers received payment on 3<sup>rd</sup> April for the work done prior to imposition of lockdown. No wages or ration has been received for the lockdown period. As Government aid, they received 5 kg rice and 1 soap. Both permanent and temporary workers have received this aid.

#Borbheel Tea Estate (Owner: Goodricke) – Wages are paid bimonthly. They received wages on 26<sup>th</sup> March for the number of days on which work was done. No wages or ration was provided for the lockdown period. No Government aid has been received.

#Rongagarh Tea Estate (Owner: Goodricke) – Wages are paid Bimonthly. Wages were paid on 28<sup>th</sup> March for the number of days on which work was done. Nothing has been paid for the lockdown period. A few workers without ration card have received 3 kg rice, 250gram lentils, 1 kg potato as government aid.

#Borgang Tea Estate (Owner: Goodricke) – Wages are paid Bimonthly. Wages were paid on 28<sup>th</sup> March for the number of days on which work was done. No wages or ration has been provided for the lockdown period. A few workers without ration card have received 3 kg rice, 250 gram lentils and 1 kg potato.

#Borgaon Tea Estate (owner: CM Pincha) – Wages are paid weekly.

No wages or ration has been paid for the lockdown period.

Government aid - Some permanent workers have received 5 kg rice.

Some without ration card have received 3 kg rice, 250 gm lentils and 1 kg potato. A few of the very poor persons (about 5 persons) have received Rs. 1000/- each.

The condition of workers of Baghmari Tea Estate, owned by M.K. Shah) has been highlighted in the news.

The status of few gardens in Dibrugarh district:

#Tingkhang Tea Estate – Wages are paid bi-monthly. Last payment was received on 24<sup>th</sup> March for work done on days prior to lockdown. Ration card holders got rice from the cooperative store. No wages or ration has been paid for the lockdown period.

#Sarojini Tea Estate – Wages are paid bi-monthly. Payment was last received on 28<sup>th</sup> March for work done on days prior to lockdown but no payment was made for the 3 days after lockdown. Ration card holders got rice from cooperative store. Those without ration cards were initially not given any rice from the cooperative. On submission of a list of 26 families, they received 3 kg 900 gms of rice from the cooperative store. Those children studying in tea garden schools received 9 kg rice each. Those who study in government schools received 3 kg each.

#Korangani Tea Estate – Wages are paid bi-monthly. Wages were paid to permanent workers on 3<sup>rd</sup> April and to temporary workers on 4<sup>th</sup> April for work done on days before lockdown. No wages or ration has been paid for the lockdown period. During the lockdown, rice was received from cooperative store.

#Rajgarh TE – Wages are bi-monthly. Wages and ration were provided on 28<sup>th</sup> March for work done on days before lockdown. During the lockdown, rice was provided from the cooperative store. Those families without ration card have not received any benefits.

#Amulya TE – Wages are paid bi-monthly. Wages were paid on 28<sup>th</sup> March for work done before lockdown. But no ration was provided. No payment has been made for the two days of lockdown.

As per information received from the ground, no payments have been made by the companies for the period of lockdown and this is just an example. The scenario is the same across Assam. Hence, it is our humble request before the Government to take appropriate action against the managements for violating its orders and further to take necessary steps to ensure provision of wages and ration to the tea garden workers.

To make the lockdown a success, it is, therefore, necessary to release the payments and ration items to workers immediately so that they are saved from dying in starvation. Also, it is requested to sanitize the gardens and the residential lines.
