INTRODUCTION

Today we all advocates and our delegates and all participants are presence in this room for gathered some knowledge about the important laws. Adv. Soumitra Karmakar Chakraborty, advocate of High Court introduces the agenda to the viewers. She says all the disabilities will get their rights of law, and the rights are protected. Advocates Sujoy Chakraborty Uttar Dinajpur lawyer assured the help to all. Social worker Dilip Das says, superstitions against disabilities are criminal offence, and lawyers are there for free services. Tribal people have their own law to protect their rights. Reporter Tapan Chakraborty sings a song to inspire the people. Social worker Bharatendra Chowdhury inspires them and encourages them to face the government offices with their need and assures them that they will get every possible help from advocates.

DISABILITY RIGHTS

The secretary of Paschim Banga Rajya Pratibandhi Sammilani, Mr. Uttam Kumar Guha says that it is very important of everything that the disable people himself have to be conscious about his rights. When he goes to any office, he should face the officer confidently. He says when Somnath Chatterjee was the speaker of the parliament, that time UN organised the first meeting to create the committee for disables. Even he mentions that according to section 92 if any officer does not listen to the disable person, it will be a offence. A disable woman even can get free lawyer. He mentions land act 1962, which refers to the “Patta” for disables. Worldwide various groups want to work for the disables, but don't get the opportunity. He suggests to all disables to contact the advocates immediately whenever their rights get violated.

LABOUR PROTECTION ACT

Mr. Himangshu Kumar Ray, Advocate of Calcutta High court says that every act changes upon the economic and social position of society. He suggested discussing the laws with each other. He assured that if the laws get violet, there is even High court to protect the rights. Even a letter to chief justice can be seen like a petition. He says that nowadays the workers of various online platforms don't get sufficient wages. He says the company should take care to the workers' health, education, even there is law for this. There is even State insurance act for any accident. There are laws available for mining workers, port workers, even for the contractual and migrant workers. He mentioned about Trade Union Act 1926. He assured all that the constitution protects every person's right.

CHILD AND LABOUR LAW

Mobina Ali, Advocate of Kolkata High court discussed about the child and women protection. According to the constitution children under 14 year's age, are prohibited for labour work. Industrial labour has some rights towards the company she also says about child and women trafficking are criminal offence. The workers has health rights too, they will get compensation if faces any injury. She points about child protection act, Beedi workers scheme, RHLN. If they approach advocates, it can take to the High court.
